# 4. REVIEW OF FINANCIAL STATE AND EXPLANATION OF MAJOR FINANCIAL TRANSACTIONS

Total Group Income for Year 2020 was S\$ 337,618 and Total Group Operating Expenditure of S\$ 328,768 resulting in a Group Net Operating Surplus of S\$ 8,850.

Included in employee benefits expenses of the Church is an amount of S\$ 139,691 (Y2019, S\$ 111,428) to Council Members who are also paid staff.

#### 5. FUTURE PLANS AND COMMITMENTS

We hold a leasehold property at 50 Serangoon North Avenue 4 #07-01 First Centre Singapore 555856. It has an unexpired lease term of 46 years. This has been used as investment property to generate rental income.

This investment property is pledged to secure loan. The fair value of this investment property at 30<sup>th</sup> November 2020 is S\$ 1,038,869.
